

NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$0.088729 per \$100 valuation has been proposed by the governing body of Ector County Hospital District.

PROPOSED TAX RATE	\$0.088729 per \$100
NO-NEW-REVENUE TAX RATE	\$0.094209 per \$100
VOTER-APPROVAL TAX RATE	\$0.088729 per \$100

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for Ector County Hospital District from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that Ector County Hospital District may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that Ector County Hospital District is not proposing to increase property taxes for the 2023 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON SEPTEMBER 19, 2023 AT 4:30PM AT AT MCH BOARD RM AT 500 W 4TH ST, ODESSA TX 79761.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, Ector County Hospital District is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the of Ector County Hospital District at their offices or by attending the public meeting mentioned above.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by Ector County Hospital District last year to the taxes proposed to be imposed on the average residence homestead by Ector County Hospital District this year.
