I. CALL TO ORDER

A. Finance Committee

1. Financial report for month ended October 31, 2018

3. Capital Expenditure Request: Merge Unity iConnect Access Image Viewer Conversion and Merge Unity System/Hardware Upgrade

Linda Carpenter, Vice President Information Technology, presented the Capital Expenditure Request: Merge Unity iConnect Access Image Viewer Conversion and Merge Unity System/Hardware Upgrade. The objective is to perform required upgrade to current Radiology System, including a hardware refresh essential for conversion to Merge Unity's iConnect Access image viewer that will allow added enhanced capabilities.

Bryn Dodd moved and Ben Quiroz seconded the motion to approve the Capital Expenditure Request: Merge Unity iConnect Access Image Viewer Conversion and Merge Unity System/Hardware Upgrade. The motion carried unanimously.

4. Consider Donation from Medical Center Health System to MCHS Foundation for ECISD

Rick Napper presented the recommendation to make a donation to the MCHS Foundation which will match the donation to provide 1170 Chromebooks to four Ector County Independent School District middle schools.
