I. CALL TO ORDER

A. Finance Committee

1. Financial reports for five months ended February 28, 2018

Bryn Dodd moved and Ben Quiroz seconded the motion to approve the summary review of the financial reports for the five months ended February 28, 2018 as presented. The motion carried.

2. Capital Expenditure Request – Cardiac Ultrasounds

Rene Rodriguez, Divisional Director, Center for Heart Disease presented the Capital Expenditure Request for two ultrasound systems for the Department of Echocardiogram.

The objective is to replace a ten year-old unit that has needed multiple repairs, is at end-of-life, and for which replacement parts are no longer produced.

The second ultrasound system is an additional unit for inpatient, outpatient, and satellite clinics in the 17 surrounding counties served. These are high use units dedicated to cardiac/vascular diseased type patients throughout the hospital and outpatient Cardiovascular Imaging Clinic at OHI.

Ben Quiroz moved and Bryn Dodd seconded the motion to approve the Capital Expenditure Request for two cardiac ultrasounds as presented. The motion carried.
